

The USDA Hogs and Pigs report showed the March 1 US hogs and pigs at 74.512 million head (record high for March 1 inventory was 76.104 in 2020), 99.8% of last year versus an average trade expectation of 101% and a range of 100.2% to 101.9%. The number of head kept for breeding was 5.980 million, 99.4% of last year versus 100.2% expected (range 99.9%-100.7%), and market hogs were 99.8% versus 100.9% expected (range 100.2%-102%). Market hogs under 50 pounds came in at 99.7% of last year versus the average trade expectation of 101.4%, 50-119 pounds 99.6% versus 101.3%, 120-179 pounds 99.7% versus 101%, 180 pounds and over 100.5% versus 100%. The December-February pig crop came in at 99.8% of last year versus an average trade expectation of 101.1% expected (range 99.9%-102.1%).

The report can be considered bullish. All three major categories, inventory, breeding herd, and market hogs came in below the lowest pre-report guess. Furthermore, weight breakdowns and farrowing intentions were under the guesses as well. June hogs have been sideways for the last couple of weeks and this report should offer a positive outlook for tomorrow's opening. Prices may quickly test the upper end of the recent range of 99.70 - 94.50.


